#### Recognition for Small-Scale Fisheries

The Artesmar® initiative recognizes two distinctive aspects of many small-scale fisheries: Their high catch selectivity and the low impact of capture gear. These two properties render products from many artisanal fisheries a more sustainable seafood choice when compared to their industrial counterparts.

### Sourcing Solutions for Seafood Businesses

Artesmar® creates a unique market identity for selectively caught seafood from artisanal fisheries. The program directly links small-scale fisheries with seafood businesses and facilitates professional management of seafood supply chains.

#### Traceability and Product Identity

Artesmar® ensures correct product identity in terms of species identification and traceability from participating fisheries to the final export product. The referring criteria for chain of custody (CoC) are subject to independent verification.

## A Holistic Approach to Fisheries Improvement

Artesmar® offers a stepwise approach to improve artisanal fisheries by tackling basic elements first and gradually addressing higher-level achievements over time. The initiative brings together fishermen, local communities, authorities, scientific institutions, fish processors and seafood buyers, which creates mutual understanding and trust and fosters active cooperation through a common vision for change and improvement.

Artesmar® aims at addressing all relevant areas of concern, from a social, economic and ecological perspective. At the crossroads of these three dimensions of sustainability, Artesmar® focuses on compliance with laws and regulations and promotes fishery co-management schemes.


#### Marginalization and Challenges of Small-Scale Fisheries

Artisanal small-scale fisheries employ more than 90% of the world's fishers and significantly contribute to global landings and trade of seafood. However, small-scale fisheries have largely been left out of the potentially rewarding process of fishery improvement and seafood certification.

This results in a debate over whether existing fishery certification schemes can be directly applied to the realities of small-scale fisheries or if there is a need for intermediate approaches towards fisheries improvement through market recognition and third-party verification.


